<p>How do I open and manage my account?</p>	<ul style="list-style-type: none"> If you are aged 18 or over and resident in the UK, you can apply for and manage your account online, 24/7 at rcibank.co.uk. Savings can also be managed via our mobile banking app, for more information click here. To keep your account open, we need to receive an initial minimum deposit of £1,000 within the first 14 days from application. Unlimited deposits can be made within the first 14 days from application (up to the maximum account balance allowed of £1m) but the first deposit must be for a minimum of £1,000. You can pay in money from your linked bank account (the UK bank account you nominate during your application) or from an existing RCI Bank savings product, subject to the Terms and Conditions of that product.
<p>Can I withdraw money?</p>	<ul style="list-style-type: none"> You can't make any withdrawals before the end of your fixed term. This includes all the payments made into the account. We will contact you, to inform you about your maturity options, 14 days and again 7 days before the maturity of your fixed term account. You may choose to: <ol style="list-style-type: none"> Reinvest your funds into another fixed term account of 1 to 5 years Choose to transfer your funds into a notice account; Choose to transfer your funds into a freedom savings account; or Choose to transfer your funds into your linked account*.

	<p>*If you would like your funds returned to your linked account, please select linked account as your maturity option.</p> <p>If we do not hear from you, we will transfer your funds to a new freedom savings account.</p> <ul style="list-style-type: none"> • The fixed term starts on the date we receive your first deposit. For example, if you made your first deposit into a 4 Year Fixed Term Account on 26 March 2026, the fixed term would start on 26 March 2026 and finish on the 25 March 2030. • Your maturity instruction will be carried out on the day after your term has finished. If this day is a weekend or Bank Holiday, your instruction will be carried out on the next working day.
